A reptile removalist's licence covers the capture and removal from, in or near any residential premises or other premises frequented by people, any herpetofauna that are likely to suffer harm if not removed from those premises and any venomous snakes or other reptiles that may be perceived to pose a threat to the safety of persons at those premises or to their pets or livestock.

### Applicant is required to:

1. provide proof of age (driver's licence, passport, or other appropriate document).
2. provide written details of length and nature of experience in reptile capture/handling, including specific reference to experience in handling venomous species if applicable.
3. provide at least one written reference and/or copy of any certification pertaining to the applicant's reptile capture/handling ability.
4. nominate the areas (suburbs if based in metropolitan Perth) that you would be willing to attend to herpetofauna call-outs. If based in the country, nominate towns.
5. be aware that a condition of such licence is the requirement that the licensee submits SIX (6) monthly returns to the Department detailing all capture, removal and release activities carried out under the licence. Return forms will be provided upon licensing.
