General Information and Instructions

What must be included in the application:

The application must include all of the relevant information required from the *Dangerous Substances (Explosives) Regulation 2004*, and any other information required by this application form.

Note the following information:

1. This form should be used by a fireworks display permit applicant who holds an ACT 'Display Operator Licence' (DOL). Should the applicant hold a corresponding interstate licence, the applicant must apply for a Display Operator Licence in the ACT under Mutual Recognition.
2. Other than this application, no other document will be accepted for reporting proposed fireworks to be used under a fireworks display permit. Applicants are to photocopy, complete, and attach to the application 'Section 12 - Fireworks Details' if insufficient space has been provided.
3. This application, and any permit issued as a result of the application, is for a fireworks display permit in accordance with Division 3.4.4 of the *Dangerous Substances (Explosives) Regulation 2004*.
4. Where a permit is issued as a result of the application, it will include a condition prohibiting the sale of explosives under the authority of the permit.
5. This permit will be valid only in the Australian Capital Territory and will not transferable.
6. This application, and any permit issued as a result of the application does not specifically or by implication authorise any explosives, including fireworks, either as explosives or as consumer fireworks.
7. Any permit issued as a result of this application is issued on the basis the display will be conducted according to all of the information in this application. The failure to comply with the information supplied may result in a contravention of the *Dangerous Substances Act 2004*.
8. If any information or document provided with this application is false or misleading, then the Director General may take disciplinary action under Part 4.4 of the *Dangerous Substances Act 2004*.

Additional Reporting Requirements for Importing Explosives:

In accordance with section 96 of the *Dangerous Substances (Explosives) Regulation 2004*, the Director General must be informed of the intention to import explosives into the ACT no later than 2 business days before the day when the explosives are to arrive. The Fireworks Display Permit holder is to use the following form for the notification of importing explosives - 'Notice of Import - Explosives - General (Excluding Queen's Birthday Supply Fireworks)'. A Fireworks Display Permit application will not be accepted for notification purposes.

Collection and Use of Personal Information:

Access Canberra WorkSafe ACT is collecting the information on this form to process your application for a fireworks display permit under section 307 the *Dangerous Substances (Explosives) Regulation 2004*. The information provided will assist in making decisions as to the suitability of the applicant to hold a licence in accordance with the Regulation.

Other information may be disclosed to Commonwealth, State and Territory government agencies with responsibility for decisions that involve, or are impacted on by, the handling of explosives. Access Canberra WorkSafe ACT may also disclose personal information to any person who is authorised by law to obtain it.
