APPROVAL OF PREMISES
GAMING AND WAGERING COMMISSION ACT 1987
(Section 55)

The *Gaming and Wagering Commission Act 1987* ("the Act") provides that gaming activities may be conducted subject to certain conditions.

Included in these conditions is the requirement for gaming to be conducted at premises approved for gaming activities.

Applications for approval of premises must be lodged in the name of the owner or lessee of the premises. For the purposes of the application a lessee is a person who occupies the premises on an ongoing basis. It does not include a person who hires a premise for a specific function.

GENERAL

All applications **MUST** be made at least seven (7) days in advance of the commencement date of the proposed function.

Where investigations or further inquiries need to be carried out, or, the application form is incomplete, it may take longer than the 7 days to determine the application.

Applications can be lodged for a single date, or, for multiple dates where a certificate may be issued for a period up to five (5) years.

The specific area where the gaming is to take place must be indicated on the application.

The appropriate Local Government Authority for the area in which the premises is situated must complete the reverse side of this application form.

REGISTRATION OF APPROVED PREMISES

Where a premises has been approved for gaming activities for a period of five (5) years, no further approval is required during the validity of the premises certificate.

Enquiries regarding already approved premises should in the first instance be directed to the owner or lessee of the premises where gaming is proposed to take place and the approval certificate sighted, or, by telephoning the Department of Racing, Gaming and Liquor on (08) 9425 1888.

Where a premises is not approved for gaming activities it will be necessary to submit an application on the prescribed form with the appropriate fee and may be made in person or by mail to the addresses stated below.

Please note that the approval of premises certificate does not authorise the conduct of gaming. A separate permit for the particular gaming activity must be applied for.

FEES

Application fees are prescribed in Schedule 1 to the *Gaming and Wagering Commission Regulations 1988*. Please refer to Schedule 1 for a list of all application fees and other charges.

Cheques are to be made payable to the "**Gaming and Wagering Commission**" (cash must not be sent through the mail). The application must be lodged at least **7 days prior to the commencement date** of the gaming function.
