## Proposal to place beehives on a pastoral lease

This application applies to beekeepers wishing to conduct beekeeping activities on a site located on pastoral lease. Such leases are managed by pastoralists through the Pastoral Land Board under the *Land Administration Act 1997*. The Department of Parks and Wildlife (DPaW) manages the issuing of apiary permits for sites on pastoral leases under section 88 and 89(2) of the *Conservation and Land Management Act 1984*.

## Proposal:

The beekeeper desires to place \_\_\_\_\_ beehives bearing the brand \_\_\_\_\_ on site/s within the said pastoral lease, as shown on the attached plan(s). Subject to a successful outcome (see 'A' below) of the proposal, the site(s) will be registered with DPaW. The beekeeper and the pastoralist recognise the provisions of the department's *Good Neighbour Policy* and in particular that DPaW may grant apiary site permits provided:

- 1 the beekeeper agrees to cooperate with the pastoralist and not interfere with their day to day operations. Should the operations of pastoralists be adversely affected by the activities of the beekeeper, the pastoralist has the option to relocate the apiary site to another position
- 2 if relocation of the location is not possible then the permit will be cancelled
- 3 the pastoralist is given the opportunity prior to issue of the permit to forward special conditions for the location of sites, access and egress conditions, supply of water, notification etc
- 4 the pastoralist is given the opportunity to provide reasons as to why the permit should not be issued
- 5 the permit is subject to cancellation if the beekeeper fails to abide by the code of conduct or the general conditions
- 6 the beekeeper will provide evidence of having a permit when requested by the pastoralist.

## Outcomes:

The beekeeper is also required to follow any additional conditions as required by the pastoralist.
