The Mines Safety and Inspection Regulations 1995 [r. 2.25] requires the applicant to submit the following documentation.

- Evidence of attaining minimum age of 21 years (e.g. birth certificate, passport or driver's licence)
- Character reference
- Current first aid certificate
- Application fee
- Evidence of two years experience on a mine site, which must include**
 - one year first hand practical experience in quarry pit operations with a minimum of three months practical experience in the use of explosives and blasting agents in a pit

** letters of experience must be provided and signed off by a responsible officer of the company in which experience has been gained using company letterhead. It should include precise details of the types of duties and dates associated with each. Drilling and blasting time must include number of shifts if experience is less than five months.

Experience records in the form of Statutory Declaration may be acceptable only in the original experience document from a mine cannot be obtained. Inquiries, if conducted, to establish accuracy of experience given in the form of a Statutory Declaration may cause delays in the finalisation of a decision on your application.
