## Prohibited Weapons Overseas Competitor Permit

P 638

This FACT sheet provides information on the requirements for obtaining an Overseas Competitor Permit - clause 17 of the *Weapons Prohibition Regulation 2009*.

It is an offence in NSW to possess a prohibited weapon without the authority of a permit.

### ***What does the Overseas Competitor Permit authorise?***

This permit authorises possession and use of a prohibited weapon to which the permit relates for the purpose of competing in a competition conducted in NSW by an approved sporting organisation.

This permit also authorises possession and use of the prohibited weapon in NSW for purposes connected with the competition.

### ***Who can apply for this permit?***

A person who is not a resident of Australia and who intends to visit NSW for competition purposes.

### ***What is the term of the permit?***

The permit issue date will be one day prior to your arrival in NSW and the permit will expire the date of your departure from NSW. The permit can be issued to you either before arrival in NSW or after arrival.

### ***How much will the permit cost?***

The prescribed fee for this permit is AUD\$127.

Your payment must accompany the application. You may pay by cheque or money order made payable to the NSW Police Force or by filling out the credit card details on the reverse of the application form.

### ***What kind of prohibited weapons are authorised by this permit?***

There are no restrictions on the type of prohibited weapon which may be authorised by this permit. However, you must be able to prove that you are authorised in your country of residence to possess and use the prohibited weapon nominated on the permit and that the nominated weapon will be used in activities being conducted at the competition by the approved sporting organisation in NSW.

Nominate on the P638 'Prohibited Weapons Overseas Competitor Genuine Reason' form the type of weapons you seek to possess and use.

### ***What safe keeping level applies to this permit?***

See the FACT Sheet '*Safe Storage Prohibited Weapons Level 1, 2 & 3*' & '*Prescribed Safe Storage for Schedule 1 Prohibited Weapons*' for the storage level that applies to the weapons nominated for your permit.

You must meet or exceed the prescribed safe storage for the weapon concerned.

### ***What do I need to send with the application?***

- \* A completed P638 'Application for a Prohibited Weapons Permit' form, and
- \* A completed 'Prohibited Weapon Overseas Competitor Genuine Reason' form, and
- \* Supporting documentation as requested on the genuine reason form.

### ***How do I apply for a Prohibited Weapon Overseas Competitor Permit?***

You must complete the P638 'Application for a Prohibited Weapons Permit' form and the 'Prohibited Weapon Overseas Competitor Genuine Reason' form and where applicable provide any supporting documentation.

# Instructions for completing the PW Permit Application Form

## PROHIBITED WEAPONS PERMIT APPLICATION FORM (P638)

### NEW APPLICATION / REAPPLICATION

Mark the appropriate box, new application or reapplication. If you currently hold, or have previously held, a firearms licence or firearms or prohibited weapon permit, enter your licence or permit number.

### SECTION A - PERMIT TYPE

From the drop down list select the type of permit for which you are applying. If the permit is not listed in the drop down list, enter 'Other' and describe the type of permit you require in the space provided.

### SECTION B - NOMINATED PERSON / PERMIT HOLDER

Insert the full name, date of birth, gender, NSW drivers licence (if held), contact phone numbers, email address and supply details for the nominated person (business) or nominated permit holder (individual). If you have been known by any other names enter your alias here.

### SECTION C - RESIDENTIAL ADDRESS

Insert your full residential address in this section.

### SECTION D - POSTAL ADDRESS

If the postal address is the same as the residential address, mark the box. If your postal address is different to your residential address, insert your postal address in this section.

### SECTION E - BUSINESS, CLUB OR GOVERNMENT AGENCY DETAILS

If this application is being made by a Business, Club or Government Agency, complete this section and attach supporting documentation.

### SECTION F - SAFEKEEPING ADDRESS OF WEAPONS

If the safekeeping address is the same as the residential address, select 'YES' in the box. If your weapon safekeeping address is different to your residential address, select 'NO' and insert the address in this section.

### SECTION G - PERSONAL HISTORY

Answer each question by selecting a 'YES' or 'NO' from the drop down list. If you answer 'YES' to any question, provide details as an attachment.

### SECTION H - DECLARATION

The application must be signed and dated by the applicant.

### SECTION I - FEE

The prescribed fee for a prohibited weapon permit is \$127. Your payment must accompany the application.
