## Prohibited Weapons Re-enactment Event Permit

This FACT sheet provides information on the requirements for obtaining a Re-enactment Event Permit - clause 21 of the *Weapons Prohibition Regulation 2009*.

It is an offence in NSW to possess a prohibited weapon without the authority of a permit.

### ***What does the Re-enactment Permit authorise?***

This permit authorises a person, on behalf of an historic or commemorative club or society or other organisation, to conduct and supervise an historical or commemorative re-enactment event or events, and to possess prohibited weapons to which the permit relates for the purposes of those events.

This permit also authorises any person who is the holder of a prohibited weapon permit, including interstate persons holding the equivalent permit issued in that State or Territory, to possess and use any prohibited weapon authorised by that permit to participate in the re-enactment event conducted under the authority of the re-enactment event permit.

You must notify local police about the event no more than 7 days prior to event taking place. Provide police with the name of the organisation conducting the event, the dates and location of the event, the purpose of the event and a copy of the permit authorising the event to take place.

### ***Who can apply for this permit?***

A person, who is a current member of an historic or commemorative club or society or approved by the Commissioner, which conducts activities or events requiring the possession or use of the prohibited weapons for which the permit is sought.

### ***What is the term of the permit?***

This permit will be issued for one event lasting several days or for periodic events over a maximum term of 5 years.

### ***How much will the permit cost?***

The prescribed fee for this permit is \$127. Your payment must accompany the application. You may pay by cheque or money order made payable to the NSW Police Force or by filling out the credit card details on the reverse of the application form.

### ***What do I need to send with the application?***

- \* A completed P638 'Application for a Prohibited Weapons Permit' form, and
- \* A completed 'Prohibited Weapon Re-enactment Event Genuine Reason' form, and
- \* A completed 'Business Declaration', and
- \* Supporting documentation as requested on the genuine reason form.

### ***What kind of prohibited weapons are authorised by this permit?***

There is no restriction on the type of prohibited weapons which may be authorised by this permit. However, you must be able to justify that possession and use of the weapons is required in connection with the genuine reason for obtaining the permit.

You must nominate the type of prohibited weapon on the relevant Genuine Reason form for the type of permit concerned. **NOTE:** Any prohibited weapon that operates by the firing of a projectile must not be loaded with any such projectile for the purposes of the event.

### ***What safe keeping level applies to this permit?***

See the FACT Sheet '*Safe Storage Prohibited Weapons Level 1, 2 & 3*' & '*Prescribed Safe Storage for Schedule 1 Prohibited Weapons*' for the storage level that applies to the weapons nominated for your permit.

You must meet or exceed the prescribed safe storage for the weapon concerned.

### ***How do I apply for a Historical Re-enactment Permit?***

You must complete the P638 'Application for a Prohibited Weapons Permit' form and the 'Prohibited Weapon Re-enactment Genuine Reason' form and where applicable provide any supporting documentation. Please see the reverse of this FACT Sheet for instructions on how to complete the P638 form.



# Instructions for completing the PW Permit Application Form

## PROHIBITED WEAPONS PERMIT APPLICATION FORM (P638)

### NEW APPLICATION / REAPPLICATION

Mark the appropriate box, new application or reapplication. If you currently hold, or have previously held, a firearms licence or firearms or prohibited weapon permit, enter your licence or permit number.

### SECTION A - PERMIT TYPE

From the drop down list select the type of permit for which you are applying. If the permit is not listed in the drop down list, enter 'Other' and describe the type of permit you require in the space provided.

### SECTION B - NOMINATED PERSON / PERMIT HOLDER

Insert the full name, date of birth, gender, NSW drivers licence (if held), contact phone numbers, email address and supply details for the nominated person (business) or nominated permit holder (individual). If you have been known by any other names enter your alias here.

### SECTION C - RESIDENTIAL ADDRESS

Insert your full residential address in this section.

### SECTION D - POSTAL ADDRESS

If the postal address is the same as the residential address, mark the box. If your postal address is different to your residential address, insert your postal address in this section.

### SECTION E - BUSINESS, CLUB OR GOVERNMENT AGENCY DETAILS

If this application is being made by a Business, Club or Government Agency, complete this section and attach supporting documentation.

### SECTION F - SAFEKEEPING ADDRESS OF WEAPONS

If the safekeeping address is the same as the residential address, select 'YES' in the box. If your weapon safekeeping address is different to your residential address, select 'NO' and insert the address in this section.

### SECTION G - PERSONAL HISTORY

Answer each question by selecting a 'YES' or 'NO' from the drop down list. If you answer 'YES' to any question, provide details as an attachment.

### SECTION H - DECLARATION

The application must be signed and dated by the applicant.

### SECTION I - FEE

The prescribed fee for a prohibited weapon permit is \$127. Your payment must accompany the application.
