### INTRODUCTION

It is important that all applicants read the following information carefully. This will assist in lodging notification to Fair Trading for registration under the *Mutual Recognition (New South Wales) Act 1992* (mutual recognition legislation).

All New South Wales licences/certificates issued for residential building and building trade work and for all Plumbing, Draining, Gasfitting, LP Gasfitting, Advanced LP Gasfitting, Electrical, Air Conditioning and Refrigeration work are subject to the provisions of the Home Building Act 1989 and, in the case of 'Mutual Recognition Registration' applications, subject also to the provisions of Mutual Recognition legislation. Once issued, even under Mutual Recognition legislation, a licence/certificate becomes subject to the provisions of the Home Building Act 1989.

### WHAT IS AUTOMATIC MUTUAL RECOGNITION?

Automatic Mutual Recognition (AMR) works in a similar manner as driver's licences for the purposes of occupational licensing. If you reside in the state in which you are licensed and are only intending to work in NSW but not reside in NSW, you may not be required to obtain a NSW occupational licence. This is subject to a reciprocity agreement between relevant regulators. A current list of the recognised registrations for the purposes of AMR is [available at the Fair Trading website](#).

Any individual who moves to NSW that intends to carry out residential building work or specialist work must obtain a licence either under the *Mutual Recognition Act (NSW) 1992*, the *Trans Tasman Mutual Recognition (New South Wales) 1996* or the *Home Building Act 1989*

### WHAT IS MUTUAL RECOGNITION?

In general terms mutual recognition means that any individual person holding an occupational licence or registration in one state/territory is entitled to a comparable licence or registration in another state/territory, where available, on lodgement of the proper notification and payment of the required fee.

### COMPANIES/PARTNERSHIPS EXCLUDED

Mutual recognition legislation applies only to individuals and occupations carried on by them. If it is intended to contract or operate in New South Wales as a **partnership** or **company** a Contractor Licence must be obtained by completing the application form for a Contractor Licence – Company/Partnership available from Fair Trading. An application **cannot** be made under mutual recognition for issue of a Contractor Licence in the name of a company or partnership.

However, an employee, member of the partnership or director of the company may, if the appropriate interstate registration is personally held by that individual, make application under the mutual recognition legislation for issue of a Qualified Supervisor Certificate or endorsed Contractor Licence in order to be proposed as the nominated supervisor for a company/partnership. An applicant making an application under mutual recognition for their individual licence or certificate may also lodge at the same time their application for a company or partnership under the *Home Building Act 1989* for consideration. Note: should the nominated supervisors application be refused the company/partnership application may be refused and the processing fee retained.

### ADDRESS

Your business or residential address must be provided. Post office box addresses may only be given as a postal address.

### TYPES OF NEW SOUTH WALES REGISTRATION

#### **Contractor Licence**

A Contractor Licence is required to contract/sub-contract and carry out or advertise for all:

- residential building work (including trade work) where the labour and material cost is more than \$5,000 (inclusive of GST)
- plumbing, draining and gasfitting work (including residential, commercial or industrial)
- electrical wiring work (including residential, commercial or industrial)
- air conditioning/refrigeration work (including residential, commercial or industrial)

### ***Qualified Supervisor Certificate***

A Qualified Supervisor Certificate is required to supervise and /or carry out without supervision:

- All residential building work (including trade work) contracted by the holder of a Contractor Licence as an employee of that licence holder (or as a member of a partnership or director of a company holding a Contractor Licence).
- All electrical wiring, plumbing, draining, gasfitting, air conditioning & refrigeration work as an employee generally (eg. for licensed contractors, hospitals, Government agencies, factories etc.) or as a member of a partnership or director of a company holding a Contractor Licence. This work may also be performed by the Certificate holder in connection with property in which they own or reside.

**A Qualified Supervisor Certificate DOES NOT permit the holder to contract, sub contract or advertise. In order to do so, a Contractor Licence MUST be held. However, Qualified Supervisor Certificate holders may carry out work in connection with property in which they own or reside.**

### ***Tradesperson Certificate***

A Tradesperson Certificate (formerly known as a Certificate of Registration) is required to carry out plumbing, draining & gasfitting work as an employee (or as a member of a partnership or director of a company holding a Contractor Licence) under the general supervision of a qualified holder of a Contractor Licence or Qualified Supervisor Certificate.

**A Tradesperson Certificate DOES NOT permit the holder to contract, sub contract, advertise or carry out work in their own right. In order to do so, a Contractor Licence MUST be held.**

## **OCCUPATIONS – WORK COVERED IN NEW SOUTH WALES**

Licences/certificates issued by Fair Trading have the occupation for which the registration has been granted endorsed on the licence/certificate card.

The work covered by the occupation category is in most instances clearly evident from the name of the category.

The work covered by the following categories is described more fully for the benefit of holders of interstate registration where there may be differences in the work covered in New South Wales and other states/territories.

**Builder** – includes all **residential** building and **residential** building trade work including cottages, multi story home units, villas, town houses and swimming pools. Specialist trade works of electrical wiring, plumbing, draining, gasfitting, LP gasfitting, air conditioning & refrigeration require separate endorsements unless such works are integral to a residential 'building' contract and are subcontracted to appropriately licensed specialist subcontractors.

**Plumber** – includes all sanitary plumbing and water plumbing work but excludes draining work and roof plumbing; which are separate categories. In NSW roof plumbing is considered to fall under the term 'residential building trade work'.

**Gasfitter** – includes work on all gas installations involving combustible gas connected to a meter of a gas company or to a compressed natural gas container but excludes LP Gasfitting and Advanced LP Gasfitting work which are separate categories and autogas installation work which is also licensed by the Motor Vehicle Repair Industry Authority (ph 13 32 20).

**LP Gasfitter** – includes liquefied petroleum gasfitting work on a gas installation designed to carry LPG in vapour phase only at pressures not exceeding 150 kilopascals but excluding autogas installation work which is also licensed by the Motor Vehicle Repair Industry Authority (ph 13 32 20).

**Advanced LP Gasfitter** – includes all liquefied petroleum gasfitting work on a gas installation or on pipes or fittings attached to any LPG container, without any restriction as to pressure and whether or not the gas will be conveyed in liquid or vapour phase but excluding autogas installation work which is also licensed by the Motor Vehicle Repair Industry Authority (ph 13 32 20).

## **FEES**

The required fee must accompany the notification for registration under the mutual recognition legislation. Failure for the correct fee to be paid at the time of lodgement may result in the Notice being determined to be incomplete which can affect the processing of your application. Cheques should be made payable to 'Fair Trading'.

This application is GST exempt (ABN 81 913 830 179). The fees for registration under mutual recognition are the same as the normal application fees for issue of a Contractor Licence, Qualified Supervisor Certificate or Tradesperson Certificate as shown in the Home Building schedule of fees and charges.

**Please note:** under certain provisions of NSW legislation, holders of a current plumbing trade 'Licence' issued by the Victorian Building Authority who have their principal place of business or residence in Victoria are exempt from any fee to obtain an equivalent registration in plumbing and gasfitting **only** from Fair Trading provided they have already paid appropriate fees to the Victorian Building Authority .

Evidence of payment must be submitted with applications and if the applicant is exempt, a refund of the fees will be arranged

## **CURRENT REGISTRATION DETAILS**

The notification for registration under the mutual recognition legislation must be accompanied by a document that is either the original or a clear copy of the instrument evidencing your existing registration. If there is no such instrument, sufficient information should be provided to identify yourself and the registration held by you.

The declaration should be signed by the person seeking registration under the mutual recognition legislation and witnessed and signed by a Justice of the Peace, or other appropriately authorised person.

If the declaration CANNOT be made in full then registration under the mutual recognition legislation CANNOT BE GRANTED and 'deemed' registration WILL NOT apply. In such instances application should be made on the normal application form available from Fair Trading. Each application is treated on its individual merits.

Please note in particular that Item ii) of the declaration refers to disciplinary proceedings including any preliminary investigations or actions that might lead to disciplinary proceedings. This means that if you are the subject of a complaint investigation in any state/territory in respect of work contracted, supervised and/or carried out by you which has not been finalised then the declaration CANNOT be made and registration under mutual recognition CANNOT BE GRANTED.

## **PROCESSING OF NOTIFICATION UNDER MUTUAL RECOGNITION**

The following notes detail the procedures for the processing of a notification for registration under the mutual recognition legislation.

### **Deemed Registration**

- A person who lodges a fully completed notice (being this application form and all required accompanying documentation) for registration under the mutual recognition legislation with the required fee is, pending the grant or refusal of 'substantive registration', taken to be registered. Such registration is called 'deemed registration'. 'Deemed registration' enables an individual to carry out their occupation in NSW until such time as they are either granted or refused a substantive registration by NSW Fair Trading. Deemed registration in one State does not of itself provide a basis for registration in another State.
- A person's deemed registration continues until it is cancelled or suspended or otherwise ceases by way of the Department granting or refusing to grant substantive registration, subject to any final or interim determination as the result of an appeal. The operation of deemed registration which enabled the individual to carry out their occupation is not affected by any decision to postpone the granting of substantive registration.
- It is essential that persons deemed to be registered are familiar with the provisions of the licensing legislation (eg. contracts, advertising, maximum deposits, insurance etc.) and local NSW regulations and codes as well as the requirements of Local Government Authorities, Water Boards etc.

### **Substantive Registration**

- 'Substantive Registration' must, except in the situation of postponement or refusal, be granted within one month after the notice is lodged with Fair Trading.
- When granted, substantive registration takes effect as from the date the notice was lodged.
- However, Fair Trading may, within one month after the notice was lodged, postpone or refuse the granting of substantive registration. Grounds for refusal or postponement include:
  - any of the statements in the notification lodged with the Department being materially false or misleading
  - any documentation or information evidencing the existing registration is not provided or is materially false or misleading
  - failure to obtain Home Warranty Insurance or seek exemption from Home Warranty Insurance requirements (Building work categories only)
  - the circumstances of the person lodging the application have materially changed since the date of the notice or the date it was lodged (grounds for postponement only)
  - the occupation in which registration is sought is not an equivalent occupation.
- Fair Trading may also seek particulars from the applicant regarding any matters that make up the notice for registration. Where such information is required, Fair Trading considers that the applicant is being provided an opportunity to amend the notice after lodgement.
- If Fair Trading neither grants, postpones or refuses the substantive registration within the period of one month after the notice is lodged, the person is entitled to substantive registration immediately at the end of that period and no objection may be taken to the notice on any of the groups on which refusal or postponement may be affected except where fraud is involved.

Fair Trading will give written notice of its decision to grant, postpone or refuse substantive registration. In the case of postponement or refusal the Department will advise of its findings on any material questions of fact, refer to the material on which the findings were based and state the reasons for its decisions.

## **INSURANCE REQUIREMENTS (Contractors only)**

Applicants for the various building work categories must provide evidence of a current certificate of eligibility in NSW to obtain Insurance under the Home Building Compensation Fund from an approved insurer, if they intend to contract over \$20,000. Certificates of eligibility must be given in the exact name(s) corresponding with that of the licence applicant(s).

Where an applicant for a contractor licence in the various building work categories does not provide evidence of holding current Eligibility for Insurance in NSW under the Home Building Compensation Fund, the licence will be endorsed with the condition 'ONLY FOR CONTRACTS NOT REQUIRING INSURANCE UNDER THE HOME BUILDING COMPENSATION FUND'.

This condition on the licence will remain on the public register until Fair Trading receives advice from the Home Building Compensation Fund or the licensee that the licence holder has eligibility for insurance, at which time the condition will be removed.

## **LODGING COMPLETED NOTIFICATION**

The completed notification form and required fee must be lodged at a Service NSW or Government Access Centre. For information on the location of your nearest Service NSW or Government Access Centre, please check our website at [www.fairtrading.nsw.gov.au](http://www.fairtrading.nsw.gov.au) or telephone 13 32 20. Please note applications are not acceptable by email/fax/mail.

The condition will be removed once Fair Trading is advised by the licensee or an insurer that insurance or eligibility for insurance has been granted. If however, you already hold eligibility for insurance under the Home Building Compensation Fund, please attach the relevant certificate of eligibility.
