Operate Safari Tour Permit Legitimate Reason Form

PLEASE READ THE FOLLOWING INFORMATION PRIOR TO COMPLETING THIS FORM

This is an **interactive** form and applies to an individual, organisation, firm or company who wish to operate organised safari tours in NSW on land for which prior approval from the land owner has been obtained.

Please complete all sections, print this form and submit with the P634 'Application for a Firearms Permit' form and any supporting documentation to the **Firearms Registry, Locked Bag 1, Murwillumbah NSW 2484.**

1. EVIDENCE OF BUSINESS/EMPLOYMENT

To be issued a Operate Safari Tour Permit, you must provide either evidence of business as a safari tour operator or evidence of employment as a tour operator.

Evidence of business as safari tour operator (including evidence to prove status as business) attached.

OR

Evidence of employment as a tour operator attached.

2. DETAILS OF THE AREAS / LOCATIONS YOU PROPOSE TO CONDUCT SAFARI TOURS

Provide details of the areas / location in which tours will operate **AND** you must provide evidence of prior written permission from the owner of any land on which you propose to conduct safari tours as an attachment .

Attach evidence of prior written permission from the owner of any land on which you propose to conduct safari tours.

3. DETAILS OF THE GAME TO BE HUNTED

Provide details of the types of game that will be hunted on the safari tours.

4. FIREARMS SAFETY TRAINING

If you have never held a firearms licence or permit in NSW, or you do not currently hold an equivalent issued firearms licence or permit interstate, you are required to complete firearm safety training for longarms.

A certificate of successful completion of an approved firearm safety training course for longarms attached (*if applicable*).

5. FIREARM SAFE KEEPING FACILITIES AND FIREARM SAFE HANDLING INSTRUCTION

Provide information below on your arrangements for safe keeping and storage of firearms at the firearm safe keeping address nominated in your firearms permit application form.

Provide details below on the firearm safe handling instruction that will be provided to participants.

FURTHER INFORMATION

It is a serious offence under the *Firearms Act 1996* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your firearms permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

INDIVIDUAL APPLICATIONS: DO NOT SEND PAYMENT WITH THIS APPLICATION - If approved you will be sent a photographic advice to attend the RTA to have your permit card issued and pay at that time.

BUSINESS, ORGANISATION OR CLUB APPLICATIONS: SEND PAYMENT OF \$500 WITH THIS APPLICATION - If approved, applications being made by a business, organisation or club are produced by the Firearms Registry and posted.

CHECKLIST - Make sure you have supplied ALL of the following required information

All applicants are required to provide:

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity** (*if no other NSW firearms licence or permit is held or has been held*).
- A Legitimate Reason** form with the relevant sections completed:
 - Evidence of business / employment
 - Details of the game to be hunted
 - Firearms safety training certificate, *if applicable*.
 - Evidence of prior written permission from the owner of any land on which you propose to conduct safari tours
 - Firearm safe storage facilities
 - Details of the firearm safe handling instruction that will be provided to participants

BUSINESS APPLICANTS ONLY - A completed P635 for each employee to be authorised by this permit AND proof of identity for each employee (*if no other NSW firearms licence or permit is held or has been held*) AND Safety Training Certificate, *if applicable*.

- Business Application - Fee \$500 (cheque, money order or credit card authority), with the application**

Individual Application - DO NOT SEND PAYMENT WITH THIS APPLICATION

If approved you will be sent a photographic advice to attend the RTA to have your permit card issued.
