PLEASE READ THE FOLLOWING INFORMATION PRIOR TO FILLING OUT THIS FORM

This form **must** accompany a Licence Application form. This genuine reason form applies to a person who wishes to operate a Security Business or a person who wishes to be employed as a Security Guard.

Please note the issuance of a Firearms Licence authorises the licensee to possess and use only the firearms permitted by the particular category of licence held eg. a Category B licence does not entitle the holder to possess or use a Category A firearm.

Possession and ownership of a firearm requires the holding of an appropriate firearms licence **and** registration of the firearm .
NOTE: A security guard may not acquire a firearm for the purposes of genuine reason Business Employment - Security Guard

The Genuine Reason of Business or Employment - Security Industry allows for the application of a Category A and /or H firearms licence only.

If this application is for employment as a **Security Guard** you must supply a current Accreditation Certificate and a copy of your current Security Industry licence.

If this application is for a **Security Business** you must supply supporting documentation as outlined in the guide "Assessment package for Security Business licence" accompanying this application.

This section is to be completed only if your application is for a Security Business.

Security Industry Master Licence Number

In addition to holding a Master Licence under the provisions of the *Security Industry Act 1997* the applicant for a security business must provide evidence to the satisfaction of the Commissioner of genuine reason and special need to possess and use firearms in connection with the security business. Failure to do so may result in delay or refusal of your application.

The guide "Genuine Reason Package Security Business" accompanying this application provides detailed information on the requirements to be met by the applicant.

The "Application Checklist" contained within the guide summarises the supporting documentation to be provided with this application. Below is a summary of the supporting documentation requirements.

You **must** supply a copy of:

- * Certificate of Registration of a Business Name
- * Master Security Business licence number (below)
- * Security Risk Assessment
- * Statutory Declaration indicating if security activities are covert or overt
- * Photograph/digital image of uniforms worn by security guards.
- * List of current clients requiring firearms for the protection of cash and other valuables.
- * Letters from at least 3 clients confirming the security company will be involved in duties that require access to firearms.
- * Business details schedule.
- * Evidence of current public liability insurance.
- * List of employees engaged to carry firearms, including individual security and firearms licence numbers and evidence of current first aid qualifications.
- * List of all other licensed employees including individual security and firearms licence numbers.
- * Details of level of training and experience of all employees engaged in security activities using firearms.
- * A schedule of firearms owned by the security firm
- * Standard operating procedures for safe keeping of firearms whilst in use.
- * Inspection Certificate of Safe Storage issued by local Police.
