### 1. LOCATION AND DETAILS OF THE CONDUCT OF THE RETRIEVING TRIAL ACTIVITIES

Provide the address/location and size of the premises/land where the retrieving trial activities will be conducted. A copy of the approval to conduct retrieving trial activities from the relevant local consent authority or person responsible for the control of the land must be supplied.

Attach a copy of the approval to conduct the activities from the relevant local consent authority or person responsible for the control of the land (eg council or landholder).

### 2. PUBLIC SAFETY MEASURES

Provide detailed information below of the measures that will be taken to ensure that all activities are conducted with proper regard for public safety.

### 3. FIREARMS SAFETY TRAINING

If you have never held a firearms licence or permit in NSW, or you do not currently hold an equivalent issued firearms licence or permit interstate, you are required to complete firearm safety training for longarms.

A certificate of successful completion of an approved firearm safety training course for longarms attached (*if applicable*).

Category A shotguns can only be used for retrieving trials. The firearms must be registered to the permit and primers only are discharged, not live ammunition.

**CHECKLIST** - Make sure you have supplied ALL of the following required information:

**All applicants are required to provide:**

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity** (*if no other NSW firearms licence or permit is held or has been held*).
- A Legitimate Reason** form with the relevant sections completed:
  - Address / location and size of the premises/land where retrieving trial activities will be conducted
  - A copy of the approval to conduct the activities from the relevant local consent authority or person responsible for the control of the land
  - Details of the measures that will be taken to ensure that all activities are conducted with proper regard for public safety
  - Firearm safety training certificate
  - Details of the firearms to be used for retrieving trial activities
  - Details of the safe keeping facilities
  - Proof of membership of a club affiliated with the Australian National Kennel Council
  - Fee \$75 (cheque, money order or credit card authority), with the application**

**BUSINESS APPLICANTS ONLY** - A completed P635 for each employee to be authorised by this permit AND proof of identity for each employee (*if no other NSW firearms licence or permit is held or has been held*) AND Safety Training Certificate, *if applicable*.
