Notes:

- 1. The fee for the certificate is \$140 for up to 4 persons per year. A further \$35 is payable for each additional person up to a maximum fee of \$350.
2. Under this exemption, your clients will not be required to individually pay the fee for recreational fishing.
3. It is not compulsory that you pay this fee, as it is ultimately your clients' responsibility to be licensed unless they are otherwise exempt.
4. A 50% Tweed River concession is available for boats that are used only in the tidal waters of the Tweed River and prescribed beach areas adjacent to the mouth of the river. Concessional exemption certificates are not valid in any other waters.

Eligibility:

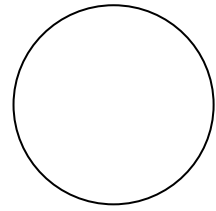
- Licensed Marine & Estuarine Charter Fishing Boats
To be eligible for issue of a recreational fishing fee exemption certificate in respect of a licensed charter boat, applicants must provide NSW Department of Primary Industries (NSW DPI) with CFB number of the boat that is the subject of the application.
Freshwater Charter Fishing Boats
To be eligible for issue of a recreational fishing fee exemption certificate in respect of a charter boat used in freshwater, applicants must:
1. Provide NSW DPI with your Australian Business Number (ABN)
2. Provide NSW DPI with a copy of the NSW Maritime Authority certificate of survey in respect of the boat that is the subject of the application.
