Commuter Wharf Permit/Voucher

Terms and Conditions

Any breach of these Terms and Conditions may lead to cancellation of the Permit or Voucher pack.

General

- Maximum berth time at any Commuter Wharf is five (5) minutes.
- Timetabled services have priority access over other Commuter Wharf users. Contracted timetabled services (ie timetabled services provided under contract to Transport for NSW) have priority over non-contracted timetabled services.
- Roads and Maritime Services may impose maximum length and tonnage limits for Commuter Wharves.

Regular Use Permit

- A Permit is NOT TRANSFERABLE to any other commercial vessel operator.
- A Permit allows the vessel(s) to pick up and/or drop off passengers at any Roads and Maritime Services Commuter Wharf.
- The Permit is not valid for use after the expiry date.

Voucher pack

- A Voucher pack may only be used by one vessel, and will display the vessel's registration/survey number.
- A Voucher pack is NOT TRANSFERABLE to any other vessel.
- The Voucher pack allows the vessel to pick up and/or drop off passengers at any Roads and Maritime Services Commuter Wharf a total of ten (10) times (ie: one wharf use per Voucher in the pack).
- The Voucher pack must be on board the vessel when it berths at a Commuter Wharf.
- Details of each wharf use (date, time, wharf name) must be recorded on a Voucher in the Voucher pack at the time of use. These details must then be provided to Roads and Maritime Services within 48 hours of the wharf use.
- The Voucher pack must be provided for inspection by Roads and Maritime Services on request.
- The Voucher pack is not valid for use after the expiry date.
