This is an **interactive** form and applies to a security firm, security guard, media organisation or media person making application to possess and use body armour vests for approved employment related purposes outside NSW.

Please complete all sections, print this form and submit with the P638 'Application for a Prohibited Weapons Permit' form and any supporting documentation to the **Firearms Registry, Locked Bag 1, Murwillumbah NSW 2484.**

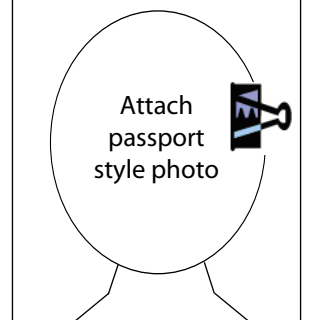

- Individual Applicants ONLY**- Passport sized colour photograph of yourself endorsed and signed on the back by a JP or police officer 'This is a true photo of NAME' attached.
- Nominated person for Business AND individual applicants** - Documentation of Proof of Identity (*if no other NSW firearms licence or permit is held or has been held*) attached. See FACT Sheet 'Proof of Identity' for acceptable 100 point ID documents.

1. EVIDENCE OF GENUINE REASON FOR OBTAINING THIS PERMIT

Provide the reasons why you require a body armour vest, including the risk involved in the activities and how the use of a body armour vest reduces that risk.

AND

- Security Firm (Business Application)** - A Risk Assessment conducted by a licensed security consultant justifying the need for body armour vests attached. **Note:** The permit will restrict the number of body armour vests the firm is authorised to acquire according to business needs.

OR

- Security Guard (Individual Application)** - Evidence of employment by a security firm and certification from employer of need for a body armour vest attached (eg. A letter on company letterhead which details required information).

OR

- Media Organisation (Business Application)** - Evidence of requirement for use of a body armour vest by employees due to civil unrest or warfare attached. **Note:** The permit will restrict the number of body armour vests the organisation is authorised to acquire according to business needs.

OR

- Media Person (person listed and authorised by media organisation permit)** - Evidence of employment by a media organisation and certification from employer of need for a body armour vest attached (eg. a letter on company letterhead with required information).



2. WEAPON SAFE KEEPING FACILITIES AND REQUIREMENTS

Level 2 safe storage applies to the storage of body armour vests.

Provide information below on your arrangements for safe keeping and storage of body armour vests at the safe keeping address nominated in your 'Application for a Prohibited Weapon Permit' P638 form.

- I have read and understand the safe keeping requirements applicable to body armour vests.
- The safe storage facilities nominated in my 'Application for a Prohibited Weapon Permit' P638 form comply with the Level 2 safe storage requirements applicable to body armour vests related to this application.

FURTHER INFORMATION

It is a serious offence under the *Weapons Prohibition Act 1998* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your weapons permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

CHECKLIST

Make sure you have supplied ALL of the following required information:

All applicants are required to provide:

- A completed P638** 'Application for a Prohibited Weapon Permit' form.
- Proof of Identity** (if no other NSW firearms licence or firearms or weapons permit is held or has been held).
- Individual applicants (media person or security guard)** - A passport sized colour photo of yourself endorsed and signed on the back by a JP or serving police officer 'This is a true photo of NAME'.
- A Genuine Reason** form with the relevant sections completed:
 - Evidence of genuine reason for obtaining a Prohibited Weapons Body Armour Vest Permit.
 - Security guard ONLY** - Evidence of employment and certification of need for body armour vest from employer.
 - Media Person ONLY** - Evidence of employment and certification of need for body armour vest from employer.
 - Security Firm ONLY** - Risk Assessment conducted by a licensed security consultant.
 - Media Organisation ONLY** - Evidence of requirement for use of a body armour vest by employees.
 - Details of weapon safe keeping facilities.
- Payment of \$127 MUST accompany this application**

Media Organisation Employees - A completed P639 for each person to be authorised by this permit AND proof of identity for each person (if no other NSW firearms licence or permit is held or has been held) AND payment of \$25 per person.

Note: Media Organisations are the only applicants that are authorised to have employees listed on their Prohibited Weapon Body Armour Vest Permit. Security Firm employees must be authorised by their own Prohibited Weapon Body Armour Vest.
