4. My dog is not a regulated dog breed (ie American pit bull terrier, pit bull terrier, Fila Brasileiro & Dogo Argentino, Japanese tosa, Perro de Presa Canario or Presa Canario, (and any crossbreed or offspring of these breeds).
5. If applicant is under the age of 18 years, the parent or guardian is deemed to be the keeper of the animal.
6. I have a suitable enclosure or adequate fencing to prevent my animal/s from escaping.
