Replacement of lost registration tag

Should a registration tag be lost or destroyed, replacement tags can be arranged at any Toowoomba Regional Council Service Centre.

Advice to dog & cat keepers

1. All dogs and cats must be registered with the Toowoomba Regional Council at three (3) months of age.
2. New residents to Toowoomba Regional Council are required to register their dog/s and cat/s upon arrival.
3. A maximum of two (2) dogs and three (3) cats only are allowed to be kept at any premises.
4. A dog or a cat must wear its registration tag at all times.
5. If a dog or cat is impounded while wandering at large it is held at an impounding facility supplied by your District Service Centre for three (3) clear working days.

Please Note*

With the introduction of the Animal Management (Cats and Dogs) Act 2008, all cats and dogs are required to be registered at 3 months of age. They are also required to be implanted with a prescribed permanent identification device (microchip) before it is 12 weeks old.

Rebate Conditions

Desexed Animals - A rebate is allowed for dogs and cats that have been neutered (desexed). The relevant certificate/form to prove rebate eligibility must be shown at time of lodging the application and may be in the form of a sterilisation certificate from a registered veterinary surgeon or a dog or cat registration application form from a previous council that states that the dog or cat is desexed.

Dog Obedience Certificates - A rebate is allowed for keepers that are in receipt of a Toowoomba Dog Obedience Certificate which must be produced at time of lodging the registration application. Please contact your Regional Service Centre for details of recognised dog obedience clubs in your district.

Guide Dogs - To be eligible, the dog must be certified as a Guide Dog.

Pensioners - To be entitled to the pensioner fee the pensioner must hold a current Pension Concession Card (Old Age, Disability Support, Supporting Parent, or Veterans Affairs Gold card). This card must be produced each time the registration fee is paid.

IF MAILING THIS APPLICATION FORM, A COPY OF THE RELEVANT CERTIFICATES MUST BE ATTACHED TO THE APPLICATION FORM.

Renewal Notices and Cancellation of Registration

A renewal notice may be sent out at the beginning of each financial year. If ownership of the Dog/s or Cat/s changes during the year, the dog or cat dies, or the dog or cat no longer resides in Toowoomba, please contact Toowoomba Regional Council on 131 TRC (131 872) or a Toowoomba Regional Council Service Centre to update the registration details to avoid future renewal notices.

IT IS THE RESPONSIBILITY OF THE KEEPER OF A DOG OR CAT TO ENSURE IT IS REGISTERED AT ALL TIMES.
