## Privacy Statement

The Department of Agriculture, Fisheries and Forestry (DAFF) collects the information on this form for the primary purpose of processing and considering your application for registration of a brand/and or earmark under the Brands Act 1915 (Act). The DAFF also collects the information on this form for the purpose of identifying the owner of brands and/or earmarks in order to facilitate the registration of ownership of brands and/or earmarks under the Act. The information you provide, including your personal information, will be used to assist the DAFF in its regulatory function under the Act and will be recorded and maintained in the Animal Identification System (AIS database) which records brands and earmark identification, and the Agricultural Property System (APS database) which records your property registration details. Both databases are secure databases accessible by authorised departmental personnel only. In order to assist in the identification and return of beasts, your personal information, such as your name, property address and postal address will be recorded on the Brands Register which is accessible by the public. Your telephone number and e-mail address will not be recorded on the Brands Register. Subject to this privacy statement, your personal information will not be disclosed to any other third party without your consent, unless the disclosure is authorised or required by law. Any personal information you provide will be treated in accordance with the DAFF Privacy and Security Statement. 



## **General:**

The issue of a particular brand or earmark depends on it not conflicting with any brands or earmark shape or positions already registered and in use by immediate neighbours or other person whose stock may come into regular contact with those of the applicant. Owners are responsible for obtaining their own branding, earmarking and tattooing instruments. Any alteration to the registration details of a brand or earmark must be notified.

## **BRAND RETURN**

A Brand Return form must be submitted in January of each year. Failure to lodge the return at any time during any three consecutive years will render the brand and/or earmark liable for cancellation.

## **HORSE & CATTLE BRANDS, SYMBOLS & EARMARKS**

All cattle over 100 kg liveweight or more must bear a registered brand before being sold. The applicant of a symbol brand must be the owner of a registered three piece horse & cattle brand before a symbol brand can be issued. A symbol brand may be used instead of the three piece brand with which it is registered. Any alteration to the registration details of the three piece brand with which a symbol brand is registered will automatically alter the registration of the symbol brand.

### **An earmark may only be used in the District for which it was registered.**

An earmark may only be used on an animal which already bears the brand with which the earmark is registered.

## **SHEEP/GOATS**

### **Sheep Brands and earmarks may only be used in the District for which they were registered.**

Registered sheep earmarks must be made in the OFF or right ear of MALE sheep and the NEAR or left ear of FEMALE sheep.

## **PIGS**

### **Pig Tattoo Brands may only be used in the District for which they were registered.**

All pigs of 30kg liveweight or more must bear a registered pig tattoo brand or NLIS tag before being sold.
