Information about a Tobacco Seller's Licence

The *Public Health Act 1997* (the Act) helps to protect the health of all Tasmanians. It covers activities which may affect public health and includes tobacco control laws. You should become familiar with the provisions about selling tobacco products in the Act because there are penalties for breaking these laws. Under the Act, you must have a licence to sell tobacco or tobacco products. Selling tobacco or tobacco products without a licence in Tasmania is an offence under the Act and carries a fine of (two penalty points) \$314 or prosecution of (50 penalty points) \$7 850.

A tobacco seller's licence expires at the end of the period specified in the licence or 12 months from the date of issue, whichever is sooner. A tobacco seller's licence is not transferable if you sell or buy a business.

This form is an **application** to sell tobacco or tobacco products in Tasmania. Payment does not mean you have been granted a licence to sell tobacco. If your application is granted, your licence will be sent to you by mail.

Your licence application cannot be processed until you have answered all questions on this form, supplied proof of age and paid the prescribed fee.

Payment Options: Lodge your completed application form and fee in person at any Service Tasmania outlet. Cheques and money orders are no longer accepted.
