TERMS AND CONDITIONS OF REGISTRATION

-  Payment must be made to Sorell Council only by cash, cheque, money order or credit card.
-  Current and valid concession cards must be produced when making the payment to receive the concession rate.
-  Sterilisation certificate must be provided for new registration of desexed dogs.
-  Dogs 6 months and over must be registered.
-  Breeders must produce a current stud prefix issued by the TCA.
-  In the case of working dogs, a demonstration may be required.
-  Owners of greyhounds must produce written evidence for concession.
-  If you have changed municipalities, you can transfer the registration of your dog for free of charge. You will need to produce written evidence of the current registration or produce the current tag.
-  Evidence of microchipping must be provided at time of registration.

CANCELLATION OF REGISTRATION

The owner of a dog must notify the Council in writing within 14 days of:

-  The dog's death, loss or removal or
-  The transfer of the dog to another municipal area.
