### Important Information

All dogs over the age of 6 months need to be registered in the appropriate class for that dog. These classes are:

- Entire Dog
- Working Dogs
- Greyhounds
- Desexed Dogs
- Guide or Hearing Dogs
- Dangerous Dogs - (Declared under the Dog Control Act 2000)
- Pure Bred Dogs
- Guard Dogs

**Evidence must be provided for registration in most of these classes. See over this page for more details.**

Pension Rate - 20% discount on the fee for the appropriate registration class applies to the first dog only.  
- registration of a second dog will attract the full registration fee.

A maximum of two dogs can be registered at a property address. If you will be keeping three or more dogs on a property, you must apply to Council for a kennel licence.

## EVIDENCE REQUIRED FOR REGISTRATION

**Desexed Dog** - Certificate of Sterilisation from a veterinary surgeon, or other documentation confirming that the dog is sterilised, or the provision of a statutory declaration.

**Pure Bred Dog** - Certificate of registration and pedigree issued by the Tasmanian Canine Association (TCA) or equivalent interstate certification, **PLUS** current membership card of the TCA.

**Working Dog** - ABN number relating to a farming business, or by providing a working demonstration to the satisfaction of a City Ranger. This only applies to breeds recognised as working dogs by the Tasmanian Canine Association.

**Greyhound** - Registration certificate or Greyhound Litter Registration papers from Greyhounds Australasia.

**Pension** - Current Centrelink Pension Concession Card OR Veterans Affairs Gold Card.
