IMPORTANT INFORMATION

You will be advised in writing whether your application is successful. You should not complete any other transaction to transfer the licence until you have been advised that this transfer application has been approved.

The transfer of the licence will not be approved unless the Transport Commission is satisfied that the proposed licence holder:

- is a natural person (i.e. an individual);
- is accredited to operate a passenger transport service in accordance with Part 2 of the [Passenger Transport Services Act 2011](#);
- is the registered operator of a vehicle that is suitable for use as a taxi and is not currently operating as a taxi under the authority of another taxi licence, or operating as a luxury hire car under the authority of a luxury hire car licence;
- has no outstanding fees due to the Commission.

The Commission may require the proposed licence holder to provide additional information to demonstrate that these conditions are met before approving the transfer.

The Commission may refuse the application for transfer if the licence has lapsed, is suspended or is subject to a notice of intention to suspend or cancel.

The transfer is of no effect until it has been approved by the Commission and has been recorded on the register of licences (the Motor Vehicle Registry).

Note to the purchaser of the licence: It is your responsibility to check the Commonwealth Personal Property Security Register for any security interests that might be registered against the licence **BEFORE** you purchase the licence. Refer to www.ppsr.gov.au for further information.
