
MUTUAL RECOGNITION LAND SURVEYOR REGISTRATION IN TASMANIA

Notice in Accordance with Section 19 of the *Mutual Recognition Act 1992*

herein apply to the Surveyor-General of Tasmania to be registered as a land surveyor pursuant to the provisions of the *Mutual Recognition Act 1992*.

I submit herewith the following with payment of \$306.00 registration fee:

- ✓ Initial Application for Registration Form OSG-A/2017
- ✓ Mutual Recognition Statutory Declaration Form OSG-C/2017 (this form)
- ✓ A letter of accreditation from the organisation that oversees registration in the jurisdiction of my current registration in Australia or New Zealand
- ✓ Other relevant documentation, such as evidence of educational qualifications and current financial membership of any relevant institutions that I would like to have published in the Register (optional).

Notes:

1. ELIGIBILITY

If you are registered as a land surveyor in another State or Territory of Australia or New Zealand, you are eligible to apply for registration as a land surveyor in Tasmania under the provisions of Mutual Recognition legislation.

2. APPLICATION

This application must be witnessed by a Justice of the Peace or a Commissioner for Declarations. If you are unable to make the statements contained in this application then you are not eligible to apply for registration in Tasmania.

3. COMMISSIONERS FOR DECLARATIONS

In Tasmania, Commissioners for Declarations include:

- Full-time teachers at schools or tertiary institutions
- Public sector permanent employees with 5 years' continuous service
- Bank officers with 5 years' continuous service
- Australia Post officers with 5 years' continuous service
- Service Tasmania officers
- Police officers
- Members of Parliament or local government councillors.

4. EVIDENCE OF CURRENT REGISTRATION

This application must be accompanied by evidence of current registration in another State or Territory of Australia or New Zealand. A letter of accreditation is adequate evidence. This must be the original or a photocopy certified as a true copy by a Justice of the Peace or a Commissioner for Declarations. Uncertified copies will not be accepted.

5. PERSONAL INFORMATION PROTECTION STATEMENT

Personal information collected from you for the purpose of registration will be used to determine whether you will be granted registration as a land surveyor and for statistical, research, planning and reporting activities. The collection of this information is authorised by the *Surveyors Act 2002* and in accordance with Section 8B(4) of the Act will be made readily available to the public and to other public sector bodies upon request. The Surveyor-General maintains a register of all surveyors registered under this Act.
