**Information for dog owners:**

- Dog 3 months and over must be registered
- Sterilised dogs must provide a registered veterinary surgeons certificate or statutory declaration
- Dogs must wear a registration tag when in a public place
- Dogs owned by pensioners – Half the fee otherwise payable (on production of the Pension Concession Card, State Concession Card or a statutory declaration quoting the pension number
- Any change in particulars contained in this application including change of ownership, the death of a dog and any change in address MUST be notified to Council immediately – see form below
- Age of owner must be 18 years or older
- Dog Exercise Area: Manners Hill Park Reserve and the northern part of the Foreshore reserve between Leake Street and Bindaring Parade.

**COMPULSORY MICROCHIPPING:**

- From 1 November 2013, all new dogs and dogs on change of ownership must be microchipped
- By 30 November 2013 all dangerous dogs, which includes restricted breeds, dogs declared dangerous and commercial security dogs, must be microchipped
- By 1 November 2015, all other dogs must be microchipped.
