Amendment to Registration – Sealed Radioactive Substances

The Radiation Safety Act 1975 requires anyone who sells or acquires radioactive substances to notify the Radiological Council in writing.

It is an offence to sell or otherwise dispose of radiation producing equipment unless the person to whom it is being transferred holds a licence or exemption granted under the Act.

This form should be completed by anyone who sells, acquires, installs or relocates any *sealed* radioactive substances. Separate forms are available for *unsealed* radioactive substances and also for irradiating apparatus and electronic products.

Notes

1. A sealed source means a radioactive material sealed in a container, or having a bonded cover, strong enough to prevent contact with and dispersal of the radioactive material under the conditions of use and wear for which that container or cover was designed.

An unsealed source means radioactive material which is not a sealed source.

2. The form **must** be signed by both parties and registration and licence numbers must be supplied for both parties. Please fill in **all** the required details then send the form to the Secretary of the Radiological Council –

Intended Use Used to indicate the intended use of the source (e.g. fixed gauge; portable moisture/density gauge; logging gauge; calibration; diagnosis; education; research; point source marker; quality assurance; HDR brachytherapy; therapy – interstitial implant).

4. Disposal:

Radioactive substances must be disposed of by means approved by the Radiological Council (which may include approval of methods of routine disposal, or return to the manufacturer/supplier, or under the authority of a disposal permit granted by Council). Should you require a disposal permit or information on appropriate disposal of a radioactive sealed source, please contact the Radiological Council.
