



## Unrestricted Asbestos Licence Application Guide

### Work Covered by a Licence

An unrestricted asbestos licence is required in Western Australia for work involving the removal of friable asbestos-containing material. Only an Unrestricted Asbestos licence holder or an employee of a licence holder may carry out this type of work.

### Licence Application

A person can apply to WorkSafe, for an unrestricted asbestos licence. The application should be sent to The Director, Business Service Centre, WorkSafe, WorkSafe, Locked Bag 14, Cloisters Square PERTH WA 6850 accompanied by the required fee (Please contact this office for the current unrestricted asbestos licence fee), which is refunded if the application is refused.

The application must include:

- Application form;
- Application fee - **\$13,296.00** as shown in Schedule 6.2A of the *Occupational Safety and Health Regulations 1996*;
- Provide a copy of the Applicant/Nominee's Primary Identification (ie: driver's licence/passport).
- Asbestos removal work procedures manual;
- Abestos Training :  
Option 1 - Asbestos removal work training manual; or  
Option 2 - Proof that the applicant has been trained in Removal of Friable Asbestos, Course code CPCCDE3015A, by a Registered Training Organisation (RTO) and a statement on company letterhead stating all employee's engaged to work under the licence will undertake the above VET course.
- List of Asbestos removal related equipment;
- Details of unrestricted asbestos licences (or equivalent) issued in other States or Territories;
- Curriculum vitae of each person employed as a manager or supervisor of unrestricted asbestos work;
- Any other relevant information that may support the application.

## Assessment of Application

The submission is assessed according to the following criteria:

- Procedures manual describes all asbestos removal methods covered by the licence and is compatible with the National Code of Practice for the Safe Removal of Asbestos;
- Procedures manual includes all legal requirements associated with removal work;
- Training Option 1 - Training manual covers the training of all employees involved in asbestos removal work and is compatible with the National Code of Practice

Training Option 2 - Proof that the applicant/nominee has been trained in the Removal of Friable Asbestos, Course code CPCDE3015A, by a Registered Training Organisation (RTO) as well as a statement from the company explaining all employees will also undertake the VET course.

- Training is carried out by a competent person;
- Equipment for asbestos work is either approved (vacuum cleaners and respiratory protection) or otherwise compatible with the National Code of Practice;
- Satisfactory performance of unrestricted asbestos work in other States and Territories, if applicable;
- The applicant will also be required to pass a written examination based on sections of the *Occupational Safety and Health Regulations 1996* relevant to asbestos removal, and the *National Code of Practice for the Safe Removal of Asbestos*;
- Satisfactory previous experience in work involving the removal of friable asbestos containing materials which shows, but is not restricted to;
  - Project names and addresses
  - Start and finish dates
  - Types and quantity of asbestos removed
  - Details regarding the applicant's role in the project
  - Contact details of persons able to verify the work conducted

At least one person must have adequate experience at a supervisory level in this type of asbestos work.

## Issue of Licence

A licence is issued by the Director, Business Service Centre if satisfied that the applicant can carry out unrestricted asbestos work in a safe and proper manner.

Each licence is endorsed with a number of conditions, which relate to the way unrestricted asbestos work is carried out. A licence is valid for a period of three years.

Option 2 - Proof that the applicant has been trained in the Removal of Friable Asbestos, Course code CPCCE3015A, by a Registered Training Organisation (RTO), and a statement on company letterhead stating all employee's engaged to work under the licence will undertake the above VET course.
- Unrestricted Asbestos removal procedures manual
- List of Unrestricted Asbestos removal related equipment
- Curriculum vitae of each person employed as a manager or supervisor of unrestricted asbestos work

## **UNRESTRICTED ASBESTOS LICENCE CONDITIONS**

Unrestricted Asbestos Licences are issued to the following conditions:

- (1) All removal of friable asbestos materials from structures or buildings is carried out in accordance with the *Occupational Safety and Health Act 1984*, the *Occupational Safety and Health Regulations 1996* and the *Code of Practice for the Safe Removal of Asbestos – 2<sup>nd</sup> Edition [NOHSC: 2002 (2005)]*.
- (2) The WorkSafe Western Australia Commissioner is given seven (7) days prior notification, in the 'approved form', of the commencement date to remove friable asbestos material from a building or structure.
- (3) A copy of the notification referred to in Condition (2) is kept for a minimum period of five (5) years.
- (4) A record of the training provided to each person who carries out unrestricted asbestos work, as required by the Code of Practice referred to in Condition (1), is kept for a minimum period of five (5) years.
- (5) A copy of the Asbestos Removal Control Plan, as required by the Code of Practice referred to in Condition (1), for each asbestos removal job, is kept for a minimum period of five (5) years.
- (6) The holder of the Unrestricted Asbestos Licence will report to the WorkSafe Commissioner any asbestos removal incidents where a person was (or was likely to have been) exposed to asbestos fibres at levels above the exposure standard.
- (7) A copy of the asbestos Clearance Certificate issued by a competent person, as required by the Code of Practice referred to in Condition (1), for each asbestos removal job, is kept for a minimum period of five (5) years.
- (8) A copy of the receipt issued by the waste disposal facility, to which asbestos material is transported for disposal, is kept for a minimum period of five (5) years.
- (9) The Chief Operations Officer of the Department of Fire and Emergency Services (DFES), Post Office Box P1174, PERTH, WESTERN AUSTRALIA, is to be notified of all intended friable asbestos removal work from buildings. The notification is to include (i) address of the premises where the removal of friable asbestos will occur (ii) commencement date and time of the removal of friable asbestos (iii) approximate amount of friable asbestos to be removed (iv) approximate amount of time it will take to remove the friable asbestos and (v) name and contact details including land-line and mobile telephone numbers of the person supervising the removal of the friable asbestos.
- (10) The holder of the Unrestricted Asbestos licence is subject to auditing and must co-operate with officers of WorkSafe, including answering questions and allowing full access to all documents relating to the carrying out of friable asbestos work which includes, but is not limited to, the documents referred to in Conditions (2), (4), (5), (6) and (7).
- (11) If the licence holder is a company, and the applicant/nominee is no longer engaged with the company, the Commissioner must be advised immediately. The licence holder must apply for the approval of another applicant/nominee.
- (12) Unrestricted asbestos license holders must within 7 days notify the WorkSafe Commissioner of the engagement event and termination event of employees or contractors who work with friable asbestos-containing material (Reg 5.46 refers).
- (13) Variations or additions to these conditions, as made by the WorkSafe Western Australia Commissioner, are complied with.

### **DECLARATION OF HOLDER OF UNRESTRICTED ASBESTOS LICENCE**

This form **must be signed by the Nominee/Competent person**. This is a person who is authorised to sign documents and is responsible for the overall Unrestricted Asbestos removal work.
