This condition will be displayed on the public register. Licence holders with this condition can only contract for work up to \$20,000.

This condition will be removed once Fair Trading is advised by the licensee or an insurer that insurance or eligibility for insurance has been granted. If, however, you already hold eligibility for insurance under the Home Building Compensation Fund, please attach the relevant certificate of eligibility.

### **Privacy Collection Notice**

NSW Fair Trading, Department of Customer Service gives priority to protecting the privacy of your personal information. - 4. As required by legislation to record information on a public register, parts of which will be published online.
